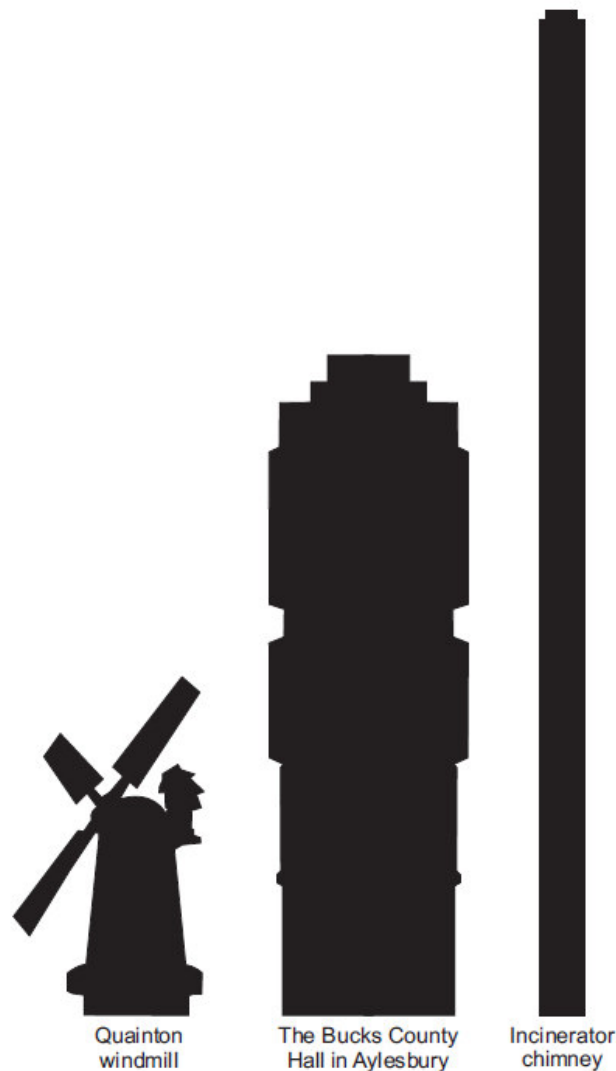


SAVI - STOP Aylesbury Vale Incineration



**JUST WHEN YOU THOUGHT IT WAS

**WRG is preparing a PLANNING APPLICATION
to build a MASS BURN INCINERATOR (MBI)
at Lower Greatmoor Farm, Edgcott**

WRG are STILL HERE & the application will be submitted towards the end of July 2010, we need to act NOW to STOP it

- Last September Bucks CC chose Covanta with their site in Bedfordshire as the supplier with whom they would negotiate over the contract to BURN our waste. **Now they have backtracked & WRG is once again being seriously considered. Even before the County Council decides which supplier it will use, WRG is planning to get approval for an incinerator.**
- **WRG** have brought in expensive & slick **SPIN DOCTORS**, called Green Issues, to launch a charm offensive aimed at persuading **YOU** that it's all going to be fine & that MBI doesn't pose a risk to your health, the environment & your rural way of life.
- The danger from **WRG** & their plans to site an **MBI** at Lower Greatmoor Farm is even greater with the threat of the high speed rail link (**HS2**) looming.
- The process is time critical - the statutory period for consultation on the planning application is likely to be during the period that **YOU ARE TAKING YOUR SUMMER HOLIDAY**.
- **WRG** have published a list of a few people & organisations it is seeking to convince before the planning application is submitted. The first meeting of this group is due to be held on 22 June, which is very short notice. **ARE YOUR VIEWS BEING REPRESENTED?** Is your parish council on the group?
- Can you see/smell Calvert landfill from your home? Even if you can't, the toxic fumes from the proposed chimney affect areas of up to 10 miles or more downwind of the incinerator. **THIS ISSUE IS AFFECTING YOU.**
- Stay alert for the planning application. Details will be on the SAVI website; in the Quainton News; in the Bucks Herald (planning applications); on Bucks CC website; **WE NEED EVERYONE TO OPPOSE IT.**
- In planning decisions where there has been opposition & the plans have been rejected, the planning authority cites the weight of **PUBLIC OPPOSITION** as **THE** significant factor in the decision to reject. Write and object, not once, not twice, but frequently to demonstrate your opposition.
- **NOW IS THE TIME TO OPPOSE THIS.**
- **SAVI** needs your support & **MONEY** - lots of it if we are to win this war. **PLEASE DIG DEEP & GIVE GENEROUSLY.** Cheques payable to **SAVI** can be sent to The Open Space - address below.
